

Medicaid Matters to Virginia

The Virginia Medicaid program covered 2 million beneficiaries as of February 2024, with approximately 97 percent enrolled in a Medicaid managed care plan. Virginia awarded new contracts under its Medicaid managed care program, Cardinal Care Managed Care (CCMC), to incumbents CVS/Aetna, Elevance/ Anthem, Sentara/Optima Health, and United Healthcare, and non-incumbent Humana. The separate foster care specialty plan contract was awarded to Elevance/Anthem. CCMC launched in January 2023 as a rebranding of the state's Medicaid program and Children's Health Insurance Program—Family Access to Medical Insurance Security Plan (FAMIS). CCMC combined the state's existing Medallion 4.0 managed care program for traditional Medicaid and the Commonwealth Coordinated Care Plus (CCC Plus) managed long-term services and supports (MLTSS) program. Implementation of the new contracts was $scheduled\ to\ begin\ July\ 1,\ 2024.\ Total\ Medicaid\ expenditures\ in\ Virginia\ were\ approximately\ \$21.1\ billion\ in\ fiscal\ 2023.$
